

# **REGULATION FOR CONTEST PARTECIPATION**

### **ARTICLE 1 (SUBJECT)**

BO it! International Illustration Contest, now in its second edition, aims at enhancing the city of Bologna through an artistic and creative interpretation of the icons that identify it, such as monuments and other symbols: Bologna described by those who live there, those who imagine it, those who discover it as a tourist, those who arrive there as a migrant.

"BO it!" Is a cultural initiative promoted by the associations <u>II Civico 32</u> and <u>MenoPerMeno</u> in Bologna, with the contribution of the <u>Del Monte Foundation</u> and <u>Coop Adriatica</u>, promoted and supported by the <u>City of Bologna</u>, <u>Bologna Welcome</u>, <u>Children's Book Fair</u>, <u>Maimeri, Galleria</u> <u>Millenium</u>, <u>CotaBo</u>, in collaboration with the <u>Academy of Fine Arts of Bologna</u> and <u>Cooperativa</u> <u>Nazareno</u>. Autori di Immagini It is also open to further territorial realities (Associations and private subjects) with whom we are in contact.

The second edition of the competition, launched with the patronage of the City of Bologna, is part of the initiatives for the UNESCO candidacy of the Arcades di Bologna.

The shape for the 2021 edition is that of the Arcades of Bologna.

Bologna has always been at the forefront and open to innovation: a reality that has always promptly collected suggestions, translated the changes taking place in society and welcomed them. The many difficulties resulting from the ongoing pandemic force us to rethink our way of living daily life, work and the relationship with the city and the community. In this scenario, the associations involved in the project have chosen to represent the new shape of 2021 as a single big hug for the entire city: the arcades of Bologna. It is an invitation to share the emotions experienced during lockdown and the hopes and wishes for the restart.

**The competition is international and is open to all**, regardless of age, it is possible to participate individually or collectively. Participants are asked to create an illustration, a graphic interpretation or a decorative pattern inside and/or outside the shape of a monument or an icon, as shown in the attached documentation, with free technique (Art.3).

### **ARTICLE 2 (PARTICIPATION TERMS AND CONDITIONS)**

- 1. This contest is open to both Italian and foreign citizens, resident and non-resident in Italy, legal or natural persons of all ages.
- 2. Candidates are responsible for the originality of their proposals and must guarantee the authorship, thus raising the organizers from any liability from any third parts' claims related to copyright and other connected issue.
- 3. If the Participant is minor in age, the form must be completed by a parent or a legal tutor.
- 4. All the proposals from a single candidate (max 3) must refer to a single application but uploaded in the form on the site through three different upload operations.
- 5. The members of the Board of the present competition and all those who have taken part or contributed in any way to the drafting of the announcement or documentation, the members of the Selection Committee and both also relatives and in-laws, including those who have ties of collaboration and/or professional relationships for any reason, cannot participate in the competition;
- 6. The incorrect or incomplete transmission of the required documentation and the sending of the processors after 11:59 pm on the expiry date of this announcement and the violation of the provisions of this announcement will also be grounds for exclusion. If the candidate submits the documentation incorrectly or incomplete by the deadline, he will be contacted by the Staff of BO it! to correct the application.

### **ARTICLE 3 (ARTWORKS ESSENTIAL REQUIREMENTS)**

The shape for the 2021 edition is that of the Arcades of Bologna.





The candidate can submit up to 3 different proposals through the form that will be activated on the website <u>www.bo-it.org</u> in the **Participate** section starting from 4/12/2020.

- 1. The proposals must be clearly related to the shape attached to this call, respecting the dimensions indicated. To facilitate the authors in this respect, a sample shape with relevant dimensions is given in Annex A. Elements outside the shape but inside the square, as long as they do not affect the recognition of the original shape supplied in Annex A, are allowed.
- 2. The jury will evaluate the proposals based on criteria related to:
  - originality
  - quality
  - readability
  - ability to visual storytelling.
- 3. The works can be carried out with any technique, manually or digitally, by the following terms:
  - a. manual proposal (e.g. on paper/cardboard, collage, photography and 3-dimensional objects) must be scanned or photographed and sent electronically using JPEG or PDF with 1 Mb maximum dimension. Furthermore the shape must be clearly recognizable and identifiable as supplied on Annex A, and it has to fit within the dimensions 30 cm height x 30 cm width (aspect ratio 1:1). In case of collage techniques all images used must be free from any kind of copyright.
  - b. **Proposal presented electronically** must be in one of indicated formats: **JPEG o PDF**, **with 1 MB maximum** dimension.

In the case of selection by the jury, the proposals would be required in high definition (300 dpi) and with dimensions 30x30 cm (1:1 scale).

- 4. Applications for participation can be submitted individually or collectively (co-authors), each participant, individually or in a group, can submit a maximum of three proposals, unpublished and not presented in previous editions.
- 5. Submissions must not contain any identifying element of the author(s). It is the task of the secretariat to identify the works with a code number to ensure anonymity.
- 6. The authors may not publish their proposals until the official communication regarding the winner and selected works.

Participants in the competition declare and guarantee that the idea, the projects and the designs are their exclusive ownership both by copyright and by the right of economic exploitation and therefore that there is no proprietary right by third parties on them.

Essential documentation required for proper participation in the tender to be submitted through the website.

## **ARTICLE 4 (MODE AND PLACE OF PROPOSALS SUBMISSIONS)**

The proposals may only be submitted by **upload** on **<u>www.bo-it.org</u>**, after filling in the participation form in the **Participate** section.

Applications for the contest may be submitted by **Friday, Monday, December 7, 2020** and received **by 23:59 (EST) Monday, March 15, 2021.** 

# **ARTICLE 5 (JURY)**

The artworks will be evaluated by a highly qualified jury composed of experts in the field of illustration, visual communication and representatives of the sponsoring institutions. Definition of the selected artworks will be carried out at the discretion of the jury members.

The names of the members will be announced at least **15 days before the deadline for delivery, in all its institutional communication channels**.

# **ARTICLE 6 (SELECTED PROPOSALS EXPOSED AND AWARDS)**

1. The jury will select the 30 finalist works which will be reproduced for the exhibitions, among which the three winners will be selected (at least one of these created by people with disabilities and migrants),

2. Participants will not have to publish the works presented before the official communication with the results of the competition.

3. The communication of the images selected by the jury will be announced by the end of **April 2021** on the website and Facebook page. Selected authors will be informed by e-mail and/or telephone.

4. The winners will be announced during the award ceremony and the inauguration of the exhibition of **the selected artworks**, which will be exhibited to the public in **an urban exhibition** that will be held in Bologna in a space in the city center, close to the same days in which it will be held **the Bologna Children's Book Fair - Fiera del Libro per Ragazzi (14-17** june 2021). Other urban exhibitions will be scheduled during the year. In the event that the health emergency is still ongoing, both the award ceremony and the final exhibition will be held online.

5. A short biography will be required for the authors of the selected artworks to be exhibited during the exhibition.

**ARTICLE 8 (PRIZES)** 

Three winning works will be awarded. The prizes are as follows:

1) First Prize "City of Bologna": € 1,200.00

2) Second Prize "Città dei Portici": € 600.00

3) Third Prize "Maimeri": Fine arts articles - supply based on the technique used by the candidate

## **ARTICLE 8 (CONTEST PHASES)**

**Phase 1**: Receipt of proposals and assessment of compliance with this Regulation.

**Phase 2**: Selection by the Jury of the 3 winning proposals among all the proposals considered valid for the competition. The best artworks will also be selected, up to a maximum of 30, in order to be exhibited to the public in an urban exhibition.

**Phase 3**: Results would be communicated to the winners and mentioned proposals through email and/ or telephone calls. Results would be published on <u>www.bo-it.org</u> and on Facebook page <u>BO it!</u> <u>Concorso Internazionale di Illustrazione</u>.

# **ARTICLE 10 (CONSENT TO PERSONAL DATA HANDLING)**

In accordance with Italian Article 13 of Legislative Decree 196/2003 we provide you with the following information, aimed at consensus of the participants to the processing of personal data: 1) The information you provide will be used, within the limits of privacy legislation, for the following purposes: analysis of projects, projects selection, invitations to meetings and for all purposes to the execution of the contest and in order to meet all their obligations under the law.

2) The treatment will take place at the headquarters of the Association II Civico 32 and will be done either through paper and / or electronic means in compliance with all security measures of security and confidentiality of the data will be kept for the time required by civil regulations and tax regulations.

3) The provision of data relating to name, address is necessary for "BO it!" contest participation. In case of refusal to provide such data will make it impossible the contest participation.
